The following conditions are in place for setting of medical or extenuating circumstances:

- a. Students will be allowed a maximum of two selfported absences between September and April, and one selfported absence between May and August;
- b. The duration of theexcused absence will be for a maximum of 48 hours from the time the SelfReported Absence form is completed through the online portal, or from 8:30am the following morning if the form is submitted after 4:30pm;
- c. The duration of the excused absence will tienate prior to the end of the 48 hour period, should the student undertake significant academic responsibilities (e.g., write a test, submit a paper) during that time;
- d. The duration of an excused absence will terminate at 8:30am on the day following the last day of classes each semester, regardless of how many days of absence have elapsed;
- e. Selfreported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations (i.e., "bellringers");
- f. Selfreporting may not be used for assessments (e.g., midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course;

Students must be in touch with their instructors no later than 24 lscafter the end of the period covered by the SeReported Absence form, to clarify how they will be expected to fulfil the academic expectations they may have missed.
