DESCRIPTION

This course will focus chiefly on the question whether the gender of the knower makes a difference in scientific (and other) knowledge. If androcentric bias characterizes even some "good" science, what does this imply for epistemology? Could more rigorous adherence to scientific method be counted upon to eliminate that bias? Alternatively, would it be better to acknowledge the impossibility of gender-neutral knowledge and insist instead on the superiority of a feminist standpoint? Or should we simply abandon altogether the idea of objective knowledge and recognize sexist and feminist theories as alternative narratives different "versions," none of which can claim epistemic superiority? (Please note that the course will focus chiefly on science rather than other forms of knowledge.)

TEXTS

Readings will be made available through the course website and the library system.

OBJECTIVES

To familiarize students with a body of literature that is often omitted from the standard philosophy curriculum.

To raise questions about the relationship between scientific objectivity and social context.

To help students develop further the expository and argumentative skills they will need to address issues that are politically charged and epistemically complex.

REQUIREMENTS

Each of the following three components will account for one-third of the final mark:

Attendance, participation, and seminar presentations

One essay (3,000 – 4,000 words)

Final exam. Study questions will be provided in advance.
