#### **COURSE DESCRIPTION**

A central pillar of the Western ethics is autonomy. A lot of good recent philosophical work in ethics has focused autonomy's connection to consent and sexuality, so this course aims to give the student a background in personal autonomy, and introduce them to criticisms of autonomy as well as reaction to these criticisms in the form of "relational autonomy". These two units will give students the tool box of concepts to deal ethically to think through sexual consent that goes beyond rigid legal definitions, grey areas of consent as well as real world, "non-ideal"

## STATEMENT ON THE USE OF GENERATIVE ARTIFICIAL INTELLIGENCE (AI)

"In this course, the use of AI (automatic translation tools, grammar checkers, ChatGPT...) is prohibited. If plagiarism or unauthorized AI use is suspected, the instructor will ask for research notes and/or drafts of assignments after the assignment has been submitted. Students must keep all notes and first drafts until the assignment is returned to them."

Personally, I think the importance of writing your own work is threefold: 1) Writing is not discovering or uncovering fully formed ideas and arguments you already have. Writing itself generates the knowledge, helps us think through an idea. Writing thinking. 2) Writing allow us to manifest our own point of view, but this can only happen if we work to develop our own "voice". 3) Just as it is going from a novice to an expert in any craft, becoming a writer is a self-transformative experience. I think using ChatGPT and other Al writing tools as a crutch when things get hard robs you of these three learning experiences and so, to that end:

#### **ACCOMMODATION**

## **ACADEMIC CONSIDERATION**

Students may request academic consideration in cases of extenuating circumstances – that is, personal circumstances beyond the student's control that have a substantial but temporary impact on the student's ability to meet essential academic requirements.
