Course Description

This course aims to present Latin American art in different museums and galleries in Canada, through the close study of artifacts from the different ancient civilizations such as the Mayas, the Incas and the Aztecs, to contemporary artists from Latin American descent living and working in Canada. Art History students will investigate artworks in the museum and gallery collections. Museum and Curatorial Studies students will have the option of researching exhibitions using different curatorial methodologies.

Students will be exposed to different geographical and historical realities of Latin America, Canadian cultural institutions and their collections of Latin American art. The course also aims for students to become acquainted and reflect on the Latino factor in the Canadian art scene. Ultimately, the goal is to consider the possibilities and limitations of these collections. This course will combine lectures by the instructor, guided discussions, and other active learning activities.

Learning outcomes

- Students will acquire knowledge of the key critical and theoretical frameworks that pertain to the art from Latin America and will be able to engage with/analyze materials according to those frameworks;
- Students will acquire the discursive/theoretical vocabularies that are utilized in debates within Latin American art and museum and curatorial studies, and will demonstrate their knowledge of the field through the deployment of the vocabulary, orally and in writing;
- Students will utilize their knowledge of appropriate methods, the vocabularies pertinent to the field, and their ability to make appropriate judgements, in order to develop a sound argument regarding collections of art from Latin America in Canada, and will be able to defend their argument according to a knowledge of scholarly works;
- Students will be able to communicate orally and in writing with regard to their research projects, and will be able to utilize different genres of writing for different purposes;
- Students will be aware of the field of research/inquiry in relation to art from Latin America in Canada, and will understand the limits/opportunities inherent to their research capacities within the framework of their studies.

Evaluation & Assignments

- Active participation (15%, throughout the semester)
- **Reading reflections and journal** (20%), due February 7
- Collecting Assignment (25%), due February 28
- **Object or exhibition-based presentation** (10%, March 28) **and essay** (30%, April 4): Brazilian art in Canada

Late assignment policy

With the exceptions of participation and the oral presentation, all assignments have a 24-hour grace period, no questions asked and no need to contact the professor. Academic Consideration:

The University recognizes that a student's ability to meet their academic responsibilities may, on occasion, be impaired by medical illness. Illness may be acute (short term), or it may be chronic (long term), or chronic with acute episodes. The University further recognizes that medical situations are deeply personal and respects the need for privacy and confidentiality in these matters. However, in order to ensure fairness and consistency for all students, academic accommodation for work representing 10% or more of the student's overall grade in the course shall be granted only in those cases where there is documentation indicating that the student was seriously affected by illness and could not reasonably be expected to meet their academic responsibilities.

Documentation shall be submitted, as soon as possible, to the appropriate Dean's office (the Office of the Dean of the student's Faculty of registration/home Faculty) together with a request for relief specifying the nature of the accommodation being requested. These documents will be retained in the student's file, and will be held in confidence in accordance with the University's Official Student Record Information Privacy Policy. Once the petition and supporting documents have been received and assessed, appropriate academic accommodation shall be determined by the Dean's Office in consultation with the student's instructor(s). Academic accommodation may include extension of deadlines, waiver of attendance requirements for classes/labs/tutorials, arranging Special Exams or Incompletes, re-weighting course requirements, or granting late withdrawals without academic penalty. Academic accommodation shall be granted only where the documentation indicates that the onset, duration and severity of the illness are such that the student could not reasonably be expected to complete their academic responsibilities. (Note – it will not be sufficient to

provide documentation indicating simply that the student "was seen for a medical reason" or "was ill.")

Whenever possible, students who require academic accommodation should provide notification and documentation in advance of due dates, examinations, etc. Students must follow up with their professors and their Academic Counselling office in a timely manner. Documentation from Family Physicians/Nurse Practitioners and Walk-In Clinics A Western Student Medical Certificate (SMC) is required where a student is seeking academic accommodation. This documentation should be obtained at the time of the initial consultation with the physician/nurse practitioner or walk-in clinic. An SMC can be downloaded at http://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf.

At the time of illness, students should make an appointment with a physician/nurse practitioner at Student Health Services. During this appointment, request a Student Medical Certificate from the Physician/Nurse Practitioner.

Students should request that an SMC be filled out. Students may bring this form with them, or request alternative Emergency Department documentation. Documentation should be secured at the time of the initial visit to the Emergency Department. Where it is not possible for a student to have an SMC completed by the attending physician, the student must request documentation sufficient to demonstrate that their ability to meet their academic responsibilities was seriously affected.

Instructors are encouraged, in the first instance, to arrange participation requirements and multiple small assignments in such a way as to allow students some flexibility.

Accommodation by Instructor for work worth less than 10% of the overall grade in a course

A student seeking academic accommodation for any work worth less than 10% must contact the instructor or follow the appropriate Department or course specific instructions provided on the course outline. In arranging accommodation, instructors will use good judgment and ensure fair treatment for all students. Instructors must indicate on the course outline how they will be dealing with work worth less than 10% of the total course grade.

In particular, instructors must indicate whether medical documentation will be required for absences, late assignments or essays, missed tests, laboratory experiments or tutorials, etc. Where medical documentation is required, such documentation must be submitted by the student directly to the appropriate Faculty Dean's office, and it will be the Dean's office that will make the determination whether accommodation is warranted. Given the University's Official Student Record Information Privacy Policy, instructors may not collect medical documentation.
