#### Prerequisite Checking:

- x It is not the Professoror Printmaking Technician's job to clean up after you. That is your responsibility.
- x Give yourself a minimum 30 minutes time to clean up properly and thoroughly.
- x You expect a clean environment when you begin working make sure you are upholding that by making a clean environment for everyone working in the Print Shop.

## Working on your Assignments by yourself

- x It is expected that you create all your assignments with your own hands.
- x Your boyfriend/girlfriend, classmate, best friend, or any other individual <u>cannot</u> do the technical work for your assignments.
- x Having unauthorized assistance to produce technical results that will be marked could be considered a scholastic offense and will result in a failing technical grade (zero = 0).
- x If you need assistance technically, you must consult Tricia, your academic advisor and/or your Accessible Education advisor.

## Creating Original Imagery for Assignments

- x It is expected that you create your printmaking assignments from original imagery that you have designed/createdyourself, whether it is a drawing, a photographor preliminary sketches in your sketchbook.
- x There may be circumstances when you need to use Google Images as visual reference for specific subject matter in your printmaking assignments; please consult me and be ready to provide a reference link.
- x Using another artist's artwork and presenting it as your own original work is considered plagiarism as outlined in Departmental and University Policies below and has serious consequences.

CAUTION:Lock your print drawer and place anything of importance in your locker. Do not steal each other's art supplies and materials . Stealing is an offense and is grounds for being removed from the university, permanently

# Academic Considerations Policy

The University recognizes that a student's ability to meet their academic responsibilities may, on occasion, be impaired by medical illness. Illness may be acute (short term), or it may be chronic (long term), or chronic with acute episodes cademic Consideration provides students with consistent, fair, and pedagogically appropriate consideration, without compromising the academic integrity of the course or program, when they have been unable to complete some component of a course due to sterm

extenuating circumstances. Students who have lorterm or chronic medical conditions (physical or mental) that may impede their ability to complete academic responsibilities are directed to seek Academic Accommodation through Accessible Education Accommodation for Students with Disabilities.

The University further recognizes that medical situations are deeply personal and respects the need for privacy and confidentiality in these matters. However, in order to ensure fairness and consistency for all students, academiconsideration for work representing 10% or more of the student's overall grade in the course shall be granted only in those cases where there is documentation indicating that the student was seriously affected by illness and could not reasonably be expected to meet their academicsponsibilities.

Documentation shall be submitted, as soon as possible and no later than 48 hours after the end of the period of absence covered, to the Academic Counselling unit or Dean's Office of the student's Home Faculty together with a request for relief specifying the nature of the academic consideration being requested. These documents will be retained in the student's file, and will be held in confidence in accordance with the University Official Student Record Information Privacy PolicyOnce the petition and supporting documents have been received and assessed, appropriate acadenciansideration shall be determined by the Dean's Office in consultation with the student's instructor(s). Academic consideration may include extension of deathes, waiver of attendance requirements for classes/labs/tutorials, arranging Special Exams or Incompletes, reweighting course requirements, or granting late withdrawals without academic penalty. Academic consideration shall be granted only where the domentation indicates that the onset, duration and severity of the illness are such that the student could not reasonably be expected to complete their academic responsibilities. (Note – it will not be sufficient to provide documentation indicating simply that the student "was seen for a medical reason" or "was ill.")

Whenever possible, students who require academiconsideration should provide notification and documentation in advance of due dates, examinations, etc. Students must follow up with their professors and their Academic Counselling office in a timely manner.

Documentation from Family Physicians/Nurse Practitioners and Walk -In Clinics A Western Student Medical Certificate (SMC) is required where a student is seeking academicconsideration. This documentation should be obtained at the time of the initial consultation with the physician/nurse practitioner or walk-in clinic. An SMC can be downloaded
